Dear Parents/Guardians:

Re: Transfers Between High Schools of Saddle River Resident Students

In August, 2004, three similar resolutions were adopted by the members of the Boards of Education of Ramsey and Northern Highlands Regional High School and our own Saddle River Board of Education. The new regulations, which went into effect immediately, alter the existing transfer policies for Saddle River residents' students attending either Ramsey or Northern Highlands high schools.

Beginning in the school year (2004-2005), Saddle River students attending either Ramsey or Northern Highlands high schools, are permitted a one-time lifetime transfer to the other high school without parental tuition expense if they notify one of the three school districts prior to the start of school in September in any school year of their desire to transfer. If this one-time request for transfer is made after the start of school at either high school, then for the remainder of that school year, parents will be responsible and charged tuition costs for that school year only. However, the Saddle River School District will pay the tuition costs in subsequent years to the appropriate high school district for any one-time transfer taking place after the start of any school year.

While this resolution changed the existing transfer policy with regard to tuition, it does not alter the fact that deciding on the most appropriate high school placement for your child is a very important decision and should not be made without due consideration and active investigation.

ARTICLE I Ineligible Student Enrollment [Adopted 8-17-2015 by Ord. No. 15-911-C]

§ 172-1. Purpose.

The purpose of this article is to prohibit and penalize any parent or other person enrolling a student in the Saddle River School District seeking free-of-charge education when such student is ineligible for free-of-charge education.

§ 172-2. Prohibited conduct.

It shall be unlawful for any person over the age of 18 to:

- A. Knowingly register or enroll a student in the Saddle River School District seeking free-of-charge education or maintain the enrollment of a student receiving free-of-charge education when the student is ineligible for free-of-charge education pursuant to N.J.S.A. Title 18A; or
- B. Knowingly assist, aid or permit a student to register or enroll in the Saddle River School District seeking free-of-charge education when the student is ineligible to attend free-of-charge pursuant to N.J.S.A. Title 18A; or
- C. Knowingly permit his or her name, address or other residence designating documentation to be utilized in the registration or enrollment of any student seeking free-of-charge education in the Saddle River School District when the student is ineligible to attend free-of-charge pursuant to N.J.S.A. Title 18A; or
- D. Not notify or inform the Saddle River School District when a student is no longer a resident in the household of that person who had previously knowingly permitted his or her name, address or other residence designating documentation to be utilized in the registration or enrollment of the student in the Saddle River School District.

§ 172-3. Determination of eligibility; registration required.

Upon the request of the Saddle River School District, the parent or guardian of a student registered in the Saddle River School District shall be required to complete a questionnaire intended to determine the student's eligibility to attend school in the Saddle River School District free of charge, in accordance with N.J.S.A. Title 18A. All residents hosting other families, with a student enrolled in the Saddle River School District in their residence, must register with the Saddle River School District and must notify the Saddle River School District when such other families no longer reside with the resident.

§ 172-4. Enforcement.

Sections 172-1, 172-2, and 172-3 may be enforced by the administrative officials of the Saddle River School District in their sole discretion.

§ 172-5. Violations and penalties.

Any person violating the provisions of §§ 172-1, 172-2, and 172-3 shall, upon conviction thereof, be sentenced to pay a fine of up to \$2,000 and, to the maximum lawful extent, make restitution to the Saddle River Board of Education. In determining the amount of restitution, the Municipal Court of the Borough of Saddle River, Bergen County, shall include amounts incurred by the Saddle River Board of Education, including but not limited to tuition costs, investigation expenses and attorneys' fees.

§ 172-6. Restitution.

Restitution ordered by the Municipal Court of the Borough of Saddle River, Bergen County, shall be paid to the Saddle River Board of Education within 30 days of such an order being final and not subject to further appeal. Unpaid restitution and fines may, upon the petition of the Saddle River Board of Education to the Municipal Court of the Borough of Saddle River, be converted into liens against the properties of the offending parties.

REGISTRATION MATERIALS

PRELIMINARY INFORMATION: PLEASE READ BEFORE PROCEEDING

The questions asked in the following pages will enable us to determine your student's eligibility to attend school in this district in accordance with New Jersey law. Please be aware that N.J.S.A. 18A:38-1 and N.J.A.C. 6A:22 require that a free public education be provided to students between the ages of 5 and 20, and to certain students under 5 and over 20 as specified in other applicable law, who are:

- Domiciled in the district, i.e., living with a parent or guardian whose permanent home is located within the district. A home is permanent when the parent or guardian intends to return to it when absent and has no present intent of moving from it, notwithstanding the existence of homes or residenceselsewhere.
- Living with a person, other than the parent or guardian, who is domiciled in the district and is supporting
 the student without compensation, as if the student were his or her own child, because the parent cannot
 support the child due to family or economic hardship.
- Living with a person domiciled in the district, other than the parent or guardian, where the parent/guardian
 is a member of the New Jersey National Guard or the reserve component of the U.S. armed forces and has
 been ordered into active military service in the U.S. armed forces in time of war or national emergency.
- Living with a parent or guardian who is temporarily residing in the district.
- The child of a parent or guardian who moves to another district as the result of being homeless.
- Placed in the home of a district resident by court order pursuant to <u>N.J.S.A.</u> 18A:38-2.
- The child of a parent or guardian who previously resided in the district but is a member of the New Jersey National Guard or the United States reserves and has been ordered to active service in time of war or national emergency pursuant to N.J.S.A. 18A:38-3(b).
- Residing on federal property within the State pursuant to N.J.S.A. 18A:38-7.7 et seq.

Note that the following do not affect a student's eligibility to enroll in school:

- Physical condition of housing or compliance with local housing ordinances or terms of lease
- Immigration/visa status, except for students holding or seeking a visa (F-1) issued specifically for the purpose of limited study on a tuition basis in a United States public secondaryschool
- Absence of a certified copy of birth certificate or other proof of a student's identity, although these must be provided within 30 days of initial enrollment pursuant to N.J.S.A. 18A:36-25.1
- Absence of student medical information, although actual attendance at school may be deferred as necessary
 in compliance with rules regarding immunization of students, N.J.A.C. 8:57-4.1 et seq.
- Absence of a student's prior educational record, although the initial educational placement of the student may be subject to revision upon receipt of records or further assessment by the district

The following forms of documentation may demonstrate a student's eligibility for enrollment in the district. Particular documentation necessary to demonstrate eligibility under specific provisions in law will be indicated in the appropriate section of the registration form.

- Property tax bills, deeds, contracts of sale, leases, mortgages, signed letters from landlords and other
 evidence of property ownership, tenancy or residency.
- Voter registrations, licenses, permits, financial account information, utility bills, delivery receipts, and other evidence of personal attachment to a particular location.
- Court orders, State agency agreements and other evidence of court or agency placements or directives.
- Receipts, bills, cancelled checks and other evidence of expenditures demonstrating personal attachment to a
 particular location, or, where applicable, to support of the student.
- Medical reports, counselor or social worker assessments, employment documents, benefit statements, and
 other evidence of circumstances demonstrating, where applicable, family or economic hardship, or
 temporary residency.
- Affidavits, certifications and sworn attestations pertaining to statutory criteria for school attendance, from the parent, legal guardian, person keeping an "affidavit student," adult student, person(s) with whom a family is living, or others as appropriate.
- Documents pertaining to military status and assignment.
- Any business record or document issued by a governmental entity.
- Any other form of documentation relevant to demonstrating entitlement to attend school.

The totality of information and documentation you offer will be considered in evaluating an application, and, unless expressly required by law, the student will not be denied enrollment based on your inability to provide certain form(s) of documentation where other acceptable evidence is presented.

You will not be asked for any information or document protected from disclosure by law, or pertaining to criteria which are not legitimate bases for determining eligibility to attend school. You may voluntarily disclose any document or information you believe will help establish that the student meets the requirements of law for entitlement to attend school in the district, but we may not, directly or indirectly, require or request:

- Income tax returns
- Documentation or information relating to citizenship or immigration/visa status, unless the student holds or
 is applying for an F-1 visa
- Documentation or information relating to compliance with local housing ordinances or conditions of tenancy
- Social security numbers

Please be aware that any initial determination of the student's eligibility to attend school in this district is subject to more thorough review and subsequent re-evaluation, and that <u>tuition may be assessed in the event that an initially admitted student is later found ineligible.</u> If your student is found ineligible, now or later, you will be provided the reasons for our decision and instructions on how to appeal. The affidavits and registration forms submitted are <u>LEGAL DOCUMENTS</u>. By signing these forms, you are certifying that the information being submitted is true to the best of your knowledge. In the event that any of the information submitted is found to be fraudulent, you may be subject to criminal and civil penalties and tuition may be assessed for any period of ineligible attendance as stated above.
